    - Dexcom G6 integrated CGM system
    - ADA 2021 Standards of Care update
      - Update 1 CGM recommendations no longer distinguished between T1 or T2 diabetes, instead recommending CGM for all pts on MDI or pump therapy
      - Update 2 Glycemic Goals A1C <7% or Tim in Range of 70% w/ time below Range
    - Provides whole story of what happens behind the scenes
      - Readings every 5 minutes, no fingersticks, includes alarms & alerts for highs/lows before they happen
      - 3 Components sensor wire, transmitter (1 every 3 months), display device/smartphone (app availability may vary by phone system)
        - 3 sensors per box, sensors are good for 10 days each
    - Most insurances cover 100%, but does require prior authorization

### **Take Back Day and Secure Your Meds**

Hi San Diego County Pharmacists,

We hope 2021 is off to a good start for you and your family.

Good news! We are excited to announce that the next Take Back Day is April 24, 2021. Over ten thousand pounds of prescription drugs were collected in San Diego County at the Take Back Day event in October 2020. We hope you will encourage your patients to participate in keeping the community safe by placing expired and/or unused medications in local drop boxes or taking them to a Take Back event.

As part of its continuing efforts to reduce drug misuse and overdose, the Drug Enforcement Administration (DEA) is launching a winter campaign urging the public to "Secure Your Meds." The current health crisis has magnified the importance of addressing the issue of controlled prescription drug misuse. With Americans spending more time at home due to the pandemic, now is a good opportunity to clean out your medicine cabinets and secure unused medications. This one action can prevent medications from getting into the hands of children and others who may misuse them.

The goal of the Secure Your Meds campaign is to raise awareness of the responsibility to keep prescription and other medications stored securely. Medications that are no longer used or have reached their expiration date should be secured until they can be disposed of in one of the 11,000 authorized, year-round collection sites, or until the next DEA National Prescription Drug Take Back Day, when patients can dispose of unused medications properly at a DEA collection sites.

Medicines that languish in homes cabinets are highly susceptible to diversion, misuse and abuse. Rates of prescription drug abuse in the United States are alarmingly high, as are the number of accidental poisonings and overdoses due to these drugs. Studies show that a majority of abused and misused prescription drugs are obtained from family and friends, including from home medicine cabinets.
